

Website - Terms and conditions

Website Usage

By using the Creative Brides website you agree that you are legally entitled to do so and that you are the account holder or are working with permission of the account holder when accessing the private log-in area of the website.

Data protection

Creative Brides will store your personal data (but not card payment details) but will not sell your personal data to third parties.

Advertising – period

All online advertising is based on a 12 month period from point of upload unless stated otherwise.

Advertising – prices and payments

A standard listing on our Directory is £60 per annum and £100 per annum for a premium listing. However these can be subject to change during the year dependent upon any special offers being run. There are also advertising opportunities elsewhere on the website and in the Creative Brides magazine. The rates are detailed in our supplier media pack and can be quoted separately.

Payment for online advertising is taken at the beginning of the advertising period for the year and payment can be made on the website using Paypal or BACS. We do not hold or pass on your card details but should you wish to pay by alternative means please feel free to contact us directly at accounts@creativebrides.co.uk and we will be happy to arrange this for you.

Advertising – cancellation policy

If you wish to terminate your online advertising with us before the 12 month period is over, you must contact us in writing. Creative Brides will then refund you for the remainder of the months left of the period and will charge a £20 administration fee to cancel the contract.

Creative Brides has the right to withdraw any advertising or listings at any point during the 12 month period, following which a refund of the remaining time will be issued. Similarly, if the advertising or listing content is not in keeping with the

Creative Brides ethos, or the cap on the Directory category has been reached, Creative Brides has the right to refuse advertising. Listings will be added to the Directory within 48 hours of acceptance of the order. Other advertising lead times will be advised separately when orders are placed, but Creative Brides will always endeavor to get your advertising online as soon as possible.
